- Eligibility & Authority to List
- By listing a property, you represent and warrant that: -?You are the legal owner or have lawful authority to list -?All information provided is accurate and not misleading -?You are compliant with all applicable Nigerian laws and regulations -?You hold all required licences or permissions (where applicable)
- PropatyHub may request evidence of authority at any time.

- Listing Content & Accuracy
- You are solely responsible for: -?Property descriptions, images, pricing, and availability -?Ensuring listings are lawful, current, and accurate -?Updating or removing listings when no longer available
- You must not: -?Misrepresent property condition, location, or pricing -?Upload misleading, deceptive, or altered images -?List properties that are already sold, let, or unavailable

- Listing Approval, Expiry & Renewal
- Listings: -?Are subject to administrative review and approval -?May expire automatically after a configured period -?May be hidden from public view upon expiry
- Expired listings: -?Remain visible to you and administrators -?May be renewed subject to Platform rules in force at the time
- PropatyHub reserves the right to: -?Reject, suspend, or remove listings at its discretion -?Modify visibility rules to protect platform integrity
